A proposal was brought about the side wall-\$13,000 to have the Stucco people come- they would completely recover the entire wall and put water proofing material on it; or \$7300 to patch the wall, paint it, and put an epoxy film over the wall by MBSI. The motion was made to table this discussion to get more details on how long we can expect this to work by Judy T. and Bill seconded. We hope to have a decision made by January.
