The cost to OLT will be for a motorized 8 ft. screen (\$250-300) and possibly a licensing product. Right now we are looking at movies that are public domain. If this takes off we could then use some of the money to buy a bigger screen, etc. Linda made the motion that we purchase the screen for the August night, Willie seconded it, and motion passed. Willie is heading this project.

The men that have been working on the new street sidewalks and brick work, said he could etch into the concrete blocks we have. Possibly put our OLT logo and the year of the building. Rudi is to check into it to see the cost involved.
