Our internet service and membership as all been updated thanks to Barry Mickelson. A special thanks to the board member that is leaving- Linda Johnson, who has faithfully served, led us in budgeting and financials, and also produced the Bensons last year and will be directing our Christmas Show.

Jessica Kropp got up and told about the upcoming show, Godspell, and encouraged everyone afterwards to get their tickets. There will also be a special \$2. Off per ticket for groups of 10 or more.

On June 20 and 27 the Arkansas Department of Education will be having workshops and meetings in our theatre. Hopefully many teachers from around the state will be introduced to the great place we have in Mena. It is also free and open to anyone who like to come learn at the workshops.
